- Identification of the organization (to extent that it is not already on the letterhead), including:
 - a. Organization name
 - b. Main address, phone number, e-mail and website
 - c. Contact person (title, address, phone and e-mail if different than main e-mail address)
 - d. IRS tax exempt status
- 2. Narrative description of your educational proposal, including:
 - a. How your proposal will address needs and improve education in under-

- resourced communities for specific, identifiable individuals
- b. How you know it will work and that your organization is the one to make it work
- c. What is the anticipated cost to achieve those results (and how much are you seeking in your grant from the Foundation)
- **3.** If you wish, one or two additional things that you think would be essential for us to consider.

If interested, please submit a letter of your interest in applying for a Brown Rudnick Charitable Foundation Relationship Grant. Only those letters of interest <u>received</u> by the Foundation no later than **4:00 p.m. EST on Friday, March 19, 2021** will be considered.
